#### Summer School Directors



##### Reinhard Busse

Professor Dr. Reinhard Busse MPH FFPH is professor and department head for health care management at Technische Universität Berlin. Besides being one of the Observatory's Associate Head of Research Policy and Head of the Berlin hub, he is a member of several scientific advisory boards and a regular consultant for WHO, the EU Commission, OECD and other international organizations within Europe and beyond as well as national health and research institutions. His research and publications focus on the methods and the contents of comparative health system analysis (with a particular emphasis on the reforms in Germany, other social health insurance countries and central and Eastern Europe, role of EU), health services research including cost-effectiveness analyses, health targets, and health technology assessment (HTA).



##### Elias Mossialos

Elias Mossialos is Brian Abel-Smith Professor of Health Policy in the Department of Social Policy at the London School of Economics and Political Science and Director of LSE Health. He is also the Co-Director of the European Observatory on Health Systems and Policies. He has served as an advisor to several agencies including WHO, the European Parliament, the European Commission, the World Bank, Ministries of Health and Social Affairs in Belgium, Brazil, Cyprus, Greece, Russian Federation, Slovenia, South Africa and Sweden and health insurance funds in Austria, Croatia and Hungary.

He has been a member of the management board of the European Medicines Evaluation Agency (2000-2003) and has contributed to the work of the International Forum on 'Common access to health care services' co-ordinated by the health ministers of Sweden, UK and New Zealand. In 2002 he won the European Health Management Association's annual prize for the best publication in health policy and management in Europe. His research interests are in health policy relating to health care systems. Currently, his particular focus is comparative health policy, addressing questions related to funding health care, pharmaceutical policies, private health insurance and the impact of EU law on health care systems.



**Nick Fahy**

Nick Fahy is head of the health information unit of the Health and Consumer Protection Directorate-General of the European Commission. His previous experience within the Commission includes health strategy, consumer protection, social protection and social exclusion issues. Before joining the European Commission he worked for the UK Department of Health on issues such as European affairs and pharmaceutical policy, and as private secretary to the then Minister of State for Public Health, Tessa Jowell MP. His university studies were in social, ethical and political philosophy.



**Willy Palm**

Willy Palm is the Dissemination development Officer of the European Observatory on Health Systems and Policies. He is responsible for organizing and leading policy dialogues with policy-makers in European countries on various health systems related issues. As a lawyer specialized in European social security law, Willy has been working mainly in the field of statutory health insurance and has been more specifically looking at the impact of EU integration on health systems. Before joining the Observatory in April 2006, Willy was the Managing Director of the International Association of Mutual benefit societies (AIM).

**John Bowis**

John Bowis is a former Member of the European Parliament and a former Conservative spokesman in the EP on the environment, health and food safety and rapporteur on the draft Directive on the application of patients' rights in cross-border healthcare. Previously he was a British Minister on the Council of Health Ministers and he was Minister for Transport and Road Safety in London. In the nineties he was an International Policy Adviser to the World Health Organisation's Collaborating Centre at the Institute of Psychiatry in London, supporting the UN's Nations for Mental Health Campaign.



**Frédéric Destrebecq**

Frédéric Destrebecq is Acting Chief Executive Officer of the European Union of Medical Specialists (UEMS – “Union européenne des médecins spécialistes”). The UEMS currently represents 1.4 million medical specialists in 35 countries and more than 45 specialties, subspecialties and multidisciplinary areas in Europe and is notably active in dealing with the harmonisation and promotion of standards in specialist training, continuing medical education and professional development as well as quality assurance in medical care. Frédéric Destrebecq's university background was in Political Sciences and International Relations at the Université Catholique de Louvain (Belgium). After working for the European Council of the Liberal Professions (CEPLIS), he moved to the UEMS in 2004, assisting the UEMS Secretary-General and Executive with particular responsibilities in EU-related matters, such as the recognition of professional qualifications, working time, cross-border healthcare.



### **Martin Dorazil**

Martin Dorazil works currently in the European Commission in the Pharma and Health Services unit in the Directorate-General for Competition. He is mainly responsible for enforcement of antitrust rules in the pharma sector. He also worked previously in the Task Force on the Pharmaceutical Sector Inquiry in DG Competition and in the Health Strategy and Health Systems Unit of the Public Health Directorate in DG Health and Consumer Protection where he was responsible for the Proposal for a Directive on Patients' rights in cross-border healthcare. Before joining the European Commission he worked in the Ministry of Interior of the Czech Republic in the Department for International and EU relations. He is a lawyer by training. He graduated in law (Mgr.) at the Palacky University in Olomouc, Czech Republic and in comparative constitutional law (LLM) at the Central European University in Budapest, Hungary.



### **Roberto Giampieretti**

National Expert (END) detached to the European Commission from the Veneto Region's administration (Italy), Roberto is Policy Officer at the DG Information Society and Media, ICT for Health, where he coordinates policy development initiatives to support large scale deployment of eHealth services and applications. Within the Veneto Region's administration Roberto operated as Technical Manager of Arsenàl.IT, the regional agency for research on eHealth, founded in 2005 under the name Telemedicine Consortium. Roberto planned and led the business development process that transformed the Telemedicine Consortium into Arsenàl.IT, whose mission is now widened to cover the whole range of eHealth applications. He holds a first-class M.Sc. degree in aeronautical engineering and a Ph.D. in structural engineering, both obtained at the Polytechnic of Milan.



### **Scott Greer**

Scott L. Greer is Assistant Professor of Health Management and Policy at the University of Michigan School of Public Health, and Senior Research Fellow at LSE Health, London School of Economics. Author or editor of six books, his work focuses on European Union health policy; devolution and health policymaking in the United Kingdom; and the territorial politics of health. He currently leads the LSE team evaluating partially elected health boards and alternative models of public participation in Scotland. His most recent books are *The Politics of European Union Health Policies* and the edited *Devolution and Social Citizenship in the United Kingdom*. His work has been published in journals including the *British Medical Journal*, *European Union Politics*, *Journal of European Public Policy*, *Journal of European Social Policy*, *Journal of Social Policy*, *Policy and Politics*, *Public Policy and Administration*, *Regional and Federal Studies*, and *Social Policy and Administration*.



### **Bernard Merkel**

Bernard Merkel, BA, MA(Econ), PhD, is the Head of the Food Safety, Health and Consumer Affairs section of the Delegation of the European Union (EU) in Washington. His previous post was Head of the Health Strategy and Health Systems Unit in the Health and Consumers Directorate General of the European Commission. In this position he led the work to produce the EU's first overall health strategy, "Together for Health", which was published in 2007, as well as developing a series of policy initiatives in relation to healthcare in the EU. Before joining the Commission he worked in the UK Department of Health and Social Security, on health policy issues, such as AIDS, child health and reform of the National Health Service, as well as social security programmes on poverty and disability. He was also for a time private secretary to the Health and Social Security Secretary. He has been a Visiting Fellow at the London School of Economics (LSE Health) and is an Honorary Senior Lecturer at the London School of Hygiene. He is a member of the Editorial Board of Eurohealth and author of a number of articles on health policy. His training is mainly in the social sciences, where he has a doctorate in political theory.



### **Gianluca Quaglio**

Gianluca Quaglio MD, is a Seconded National Expert at the European Commission, from the Veneto Region's administration. He works as a Policy Officer in DG Research, Health Directorate, where he contributes to the monitoring of the research developments in the field of infectious diseases. He participates in the preparation of the annual Work Programmes for FP7 and the dissemination of research results. His research activities have resulted in a number of publications in national and international peer review journals. He also worked in rehabilitation and public health projects for the Italian Co-operation Agency, Rome, Italy, and the European Commission in the Balkan area.



### **Francesco Ronfini**

Francesco Ronfini is currently working as legal manager for the Innovative Medicines Initiative Joint Undertaking (IMI JU) a public-private partnership between the European Union and the European Federation of Pharmaceutical Industries and Associations (EFPIA). Before joining IMI JU he had a long experience as lawyer and took various positions as public manager. Since 1995 he worked in a law firm as senior advisor on European Union laws and policies. In 2001 he joined the Veneto Region administration working in its Representation Office in Brussels, where he was the liaison officer between with EU Institutions and International health stakeholders. He was also entrusted as the Veneto Region representative with the activities of the Council of the European Union (EPSCO configuration) taking part in the EU process decision making. He was also the Chair of the European Regional and local Health Authorities(EUREGHA) a network of more than 100 regional and local Authorities across the Member States active in the public health field. In 2009 he joined the European Commission working for DG Research-Directorate Health as legal adviser. Mr. Ronfini is also editor of several reports on the development of EU law and policies particularly in the field of Public Health, Social Affairs, Research and Internal Market. He is married with Milena and father of two sons.



### **Matthias Wismar**

Matthias Wismar holds a doctorate in political sciences. He is the Senior Health Policy Analyst at the European Observatory on Health Systems and Policies. He has been technical consultant, and member of scientific advisory boards on the supranational, national and regional level. Currently, his research focuses on health impact assessment and on good governance and stewardship in terms of health policy formulation and implementation. His research interests cover a wide range of topics including European integration, mental health, health care policy and health promotion and prevention. Before joining the Observatory he was the head of the health policy unit at the public health department of Medical School Hannover (Germany).

### **Luigi Bertinato**

Dr. Luigi Bertinato (MD, PhD) has been Director of the Office for International Affairs at the Department of Health and Social Services of the Veneto Region, based in Venice since 1998. Previously he worked at WHO, at the Italian National Institute of Health and the Italian Agency for Regional Health Care Services, and the Technical Cabinet of the former Italian Minister of Health, Professor E. Guzzanti. Born in Verona on 27th May 1961, Dr. Luca Coletto started his political career in Verona Province as Environment and Fauna Policies Councillor (Hunt and Fishing in particular) from 2004 to 2009. Meanwhile he also started to be involved in the Lega Nord (Italian Party) as responsible for the Local Organization of Verona Province. Hans Kluge is Senior Strategic Adviser to the Regional Director; Acting Director, Health Systems and Public Health, and Regional Director's Special Representative to Combat Multidrug resistant Tuberculosis in the WHO European Region for the WHO Regional Office for Europe. He is a Medical Doctor with a Masters degree in Public Health and Infectious Diseases.

Previously based in the WHO Country Office in Myanmar (Teamleader and Adviser to the Ministry of Health on HIV/AIDS, TB and malaria), and the WHO Director-General Special Representative Office in Moscow, he has a wealth of country and management experience spanning across several WHO regions.



### **Dorijan Marušič**

Dorijan Marušič is the current Slovenian Minister of Health. Trained as a medical doctor, specialised in internal medicine he started as the head of the intensive therapy unit at Izola General Hospital in 1998, and in May 2002 became the medical director. In December 2000, he was appointed State Secretary at the Ministry of Health of the Republic of Slovenia and re-appointed to the same position in 2004. In 2003, he enrolled in post-graduate studies in management of non-profit organisations at the Faculty of Social Sciences, University of Ljubljana. Prior to his nomination for Minister of Health, he was an adviser to the Director-General of the Health Insurance Institute of the Republic of Slovenia and engaged in a clinic as a specialist in cardiology.

Dr Marušič is the author or co-author of more than 200 scientific works published in professional journals and collections. He has also published over 350 popular articles. He has lectured and participated in a number of conferences and expert meetings. Dr Marušič heads the Coronary Society of Slovenian Istria and is the vice-president of the expert council of the Association of Coronary Societies and Clubs of Slovenia. He is a member of the Slovenian Society for Emergency Medicine, the Slovenian Society of Anaesthesiology and Intensive Care Medicine, and the Slovenian Society of Cardiology.



**Bujar Osmani**

Dr Bujar Osmani is the Minister of Health of the Former Yugoslav Republic of Macedonia. Trained as a medical doctor, he specialised in general surgery at the Medical faculty of Skopje.



**Ilaria Passarani**

Ilaria Passarani joined the European Consumers Organization (BEUC) in 2006. As senior policy officer her main function is to provide BEUC and its members, intelligence, information and advice on EU health policies. Ilaria is a member of the European Medicines Agency committee with patients and consumers organizations (PCWP) and represents BEUC in the EU health policy Forum, in the e-health users' stakeholders group and in the EUnetHTA stakeholder Forum. She is also scientific researcher at the Faculty of Health, Medicine and Life sciences of the Maastricht University. She previously worked in the International health and social affairs office of the Veneto Regional Government and in the health department of the Italian Permanent Representation to the European Union. **Pablo Rivero**

Pablo Rivero, lawyer and economist, is presently Director General of Quality of the National health System of Spain with the goal of developing the Strategic Health Quality Plan for the country, including clinical excellence lines, CDM strategies, advanced information systems and eHealth. He has held leading positions within the private and public sector. He has been Deputy Minister of the Ministry of Finance & Economic Affairs, Deputy Minister of Strategic Planning & Coordination for the Regional Presidency of the Government of the Balearic Islands (Spain), and Deputy Minister of Planning and Finance for the Ministry of Health of the Balearic Islands (Spain). He was the Regional Director of Autonomic Development for the consulting firm Gedas S.A. (Volkswagen Group) in Spain. In 2004, he was appointed Director General of Innovation of the Ministry of Health in Andalusia (Spain) to lead the development of the autonomic e-Health Innovation Strategic Plan. In 2006, he co-chaired the European High-Level e-Health Conference, in Malaga (Spain), which brought together Ministers of Health and policy-making leaders from the European Union, to discuss common challenges and develop common approaches to meet them. In 2007, he was appointed Vice president and Senior Advisor of Health of the Calgary Health Region in Canada, with the objective of improving citizen engagement through innovation and to promote international collaboration to share best practices.



### **Miklós Szócska**

Dr. Miklós Szócska is the new Minister of Health for Hungary. After he graduated at the Semmelweis University of Medicine in 1989, he together with colleagues initiated the creation of the Health Services Management Training Centre, which was established in 1995. As deputy Director he was responsible for the every day operations. In June 2000 he became the acting director of the Centre. Miklós Szócska holds a Master of Public Administration degree from John F. Kennedy School of Government at Harvard University, and a Ph.D. from the Semmelweis University in the field of change management. His research activities covered various domains of health management and policy, including critical aspects of management of change, migration of health professionals and the implications of social network studies on the organisation of health care systems. Among other public service duties, Miklós was member of the Supervisory Board of the National Health Insurance Fund Between 1992 and 1993, elected by the National Parliament. He also served on the boards of the European Health Management Association and the European Health Property Network.



### **Erio Ziglio**

Erio Ziglio is Head of the European Office for Investment for Health and Development at the World Health Organization (WHO) in Venice. Dr. Ziglio worked for the European Commission for three years before joining the WHO Regional Office for Europe in 1992. His field of expertise is decision-making applied to the area of health and social economic developments, social and economic determinants of health, futures' research, and organizational development. Dr. Ziglio has held an honorary professorship from the University of York; has been a lecturer at Yale University, USA; and an honorary research fellow at the University of Edinburgh, Scotland. Dr. Ziglio has a degree in medical sociology, post-graduate studies in evaluation research and a Ph.D. in social policy from the University of Edinburgh.
